It must be recognized that this is not an issue of victims failing to protect themselves. This is an issue of perpetrators failing to be law-abiding citizens. This issue does not speak to the need for women, or any other at-risk group or subgroup, to police themselves and restrict their movements. This speaks to the lack of safety and law enforcement.

Your idea that women and other victims should simply live their lives less fully and follow some ridiculous plan to ensure they do not "expose themselves to danger" or "leave themselves open to be abused" is discrimination and it gives power to perpetrators of violence.

The victim cannot carry the blame for crimes enacted against him/her. Regardless of place relationship as circumstance it; absolutely unacceptable a Chat (Off) In to another human being.

Your bold victim-blaming and victim-shaming comment on this issue is especially disgusting given your position as Consul General to New York. You clearly lack sensitivity to the issue of gender-based violence, not to mention knowledge on the causes and effects it has on victims. Perhaps someone should be appointed by the government - or by you, personally - to vet people before we, as women, enter into relationships in order to determine whether or not interacting with them would expose us to danger? That may be your life's calling, actually. You belong in The Bahamas, approving relationships and interactions for 51% of our population, rather than living and working in one of the most progressive cities in the world.

Maybe we should only travel in groups, and ensure we always have at least one man at our side to "constantly watch over" us so you don't have to be bothered with this conversation at all. Women are probably just a huge inconvenience to you, attracting endless abuse by failing to protect themselves, huh? The pain, hardship, secrecy, health issues, loss of income, and damage to family life experience by victims of abuse must be quite the burden for you to carry.

I suggest you find a way to see past your male privilege instead of trying to add to it, building it higher and higher, increasing the barriers to women's rights, equality, and safety. See the perpetrators for who they are, and see the victims for who they are. Recognize which needs protection, and which needs to make adjustment to their lives.
