DATA HIGHLIGHTS

- In 2015 a total of 9,208 work permits were issued. Male's received 67% or 6,215 work permits whereas females received 2,993 or 33% of the work permits.

Occupational Level:

- Forty-four percent (44%) of the work permits were granted to workers in the Elementary Occupational group. Sixty-five percent (65%) of the work permits granted to persons in this group were Haitians.
- Skilled Agricultural, Forestry and Fishery workers was granted 949 or 10% of the total permits issued. Eighty percent (80%) of this group were Haitians.
- This was followed by Professionals, Science and Engineering Professionals with 927 or ten percent (10%) of the total work permits. Fifteen percent (15%) of this group were Americans and fifteen percent (15%) Jamaicans.
- The least amount of work permits granted (22 or 0.2%) was in the Plant & Machine Operators and Assemblers category.

Industry Level:

- The industry receiving the majority of the work permits in 2015 was the Accommodation and Food Service Activities Industry (Hotel) with 1,144 or 12% of the work permits granted. Eighty percent (80%) of this group were males.
- This was followed by the Construction Industry receiving 689 or 7% of the total permits issued. Ninety-six percent (96%) of this group were males.
- The Manufacturing Industry was issued 539 or 5% of the total work permits for 2015. Ninety-seven percent (97%) of this group were males.

Nationalities

- The majority of the work permits 3,360 or 36% were issued to Haitians.
- This was followed by Jamaicans with 1,075 or 11% of the permits issued.
- Philippine nationals received 1,033 or 11% of the permits issued.
